#### 1. Introduction

## 1.1. Activities and Organisation of ENEO CAMEROON S.A.

ENEO CAMEROON S.A. (ENEO) is a company tasked with electricity power generation and production throughout Cameroon. ENEO Cameroon S.A. employs close to 3,598 permanent workers.

# 1.2. Purpose of the Call for Tenders, Nature of Services

The purpose of this call for tenders shall be to Design, Fund, Construct and Sell Electricity from Solar Power Plants to ENEO. **LOT 1**: Banyo, Touboro, and Ngaoundal; **LOT 2**: Yoko, Yokadouma and Moloundou

Consequently, ENEO Cameroon S.A. is inviting, through this call for tenders notice, interested companies to submit their best bids.

# 1.3. Participation and Origin

- Participation in this call for tenders shall be open to solar power plant construction companies.
- Companies participating in this Call for Tenders shall be selected based on the evaluation and qualification criteria stated in the Tender Document.
- Companies participating in this Call for Tenders shall undertake to comply with the "Anti-Corruption and Anti-Money Laundering Provisions" attached to the Tender Document.

No answer given by or on behalf of ENEO Cameroon S.A. As in response to this Call for Tenders shall constitute an agreement or a contract between ENEO Cameroon S.A. and any bidder, unless ENEO Cameroon S.A. so expressly states.

Bidders responding to this Call for Tenders shall be responsible for the corresponding costs and expenses. All costs pertaining to this call for tenders until the contract (preparation of bids, site visit, additional information needed, negotiations, any other research performed by a bidder) is signed, and without the foregoing being exhaustive, shall be borne solely by bidders and shall not under any circumstance be reimbursed by ENEO Cameroon S.A. or any other entity belonging to or of which ENEO Cameroon S.A. is subsidiary regardless of whether or not the contract is awarded.

## 7. Confidentiality

This call for tenders and information it contains shall be confidential and may not be used for purposes other than preparation of an answer to this call for tenders. Any unauthorised use, by a bidder, of information contained in this call for tenders may lead to disqualification of such a bidder.

This Call for Tenders and corresponding documents are and shall remain the property of ENEO Cameroon S.A. and any party that receives a copy thereof will return it at the request of ENEO.

Bidders shall note that information they provide may be made public by ENEO Cameroon S.A. at the end of the call for tenders process, excluding limited information ENEO Cameroon S.A. considers sensitive commercial information that could adversely affect the business position of bidders if disclosed. To avoid any doubt, ENEO Cameroon S.A. alone shall have the power to decide whether disclosure exemptions may apply or not. Trade secrets and

sensitive personal information shall be examples of instances where ENEO Cameroon S.A. may accept that confidentiality is justified owing to the foregoing. Information bidders think should remain confidential based on the foregoing shall be clearly labelled as such in bids.

#### 8. Bid Terms and Conditions

Bids sent to ENEO Cameroon S.A. shall be considered subject to these terms and conditions, unless ENEO Cameroon S.A. expressly agrees, beforehand and in writing, to the contrary. Any alternative term and condition proposed on behalf of a bidder shall, if incompatible with these terms and conditions, be considered as rejected by ENEO Cameroon S.A., unless the latter expressly accepts such in writing.

### 9. Collusion

#### A bidder that:

- a. sets or changes the amount of its bid by or pursuant to an agreement or arrangement with any other person; or
- b. shares with a party other than ENEO Cameroon S.A. the actual or approximate amount of its bid (unless this communication takes place confidentially to obtain estimates needed to prepare a bid); or
- c. reaches an agreement or arranges with any other party so that it does not submit a bid or for the amount of any bid to submit; or
- d. offers or accepts to pay or give or pay or gives a sum of money, an incentive or valuable incentive directly or indirectly to any party for having made or initiated together with any other bid or draft bid for services;
- e. approaches directly or indirectly an ENEO Cameroon S.A. Employee or any other member of the Board of Directors of ENEO Cameroon S.A. concerning this call for tenders or that obtains or tries to obtain directly or indirectly information from these people concerning any other bid to this call for tenders.

Shall be disqualified without prejudice to any other civil remedy available to ENEO Cameroon S.A. and without prejudice to any criminal liability that such behaviour could trigger.

### 10. Warranty from the Mother Company

In case a bidder is a subsidiary, it shall, under its bid, confirm that its mother company vouches for its bid.

#### 11. Validity of Bids

Bids shall be valid for 90 days as from the deadline for submission of bids.

#### 12. Addendum and Cancellation of the Call for Tenders

- 12.1. ENEO Cameroon S.A. shall reserve the right, as necessary, to subsequently make any amendment to this Call for Tenders or not to respond to bids.
- 12.2.ENEO Cameroon S.A. may, until the contract is signed, either cancel the Call for Tenders or cancel the procedure for performance of the contract without the possibility for bidders to demand any compensation whatsoever.
- 12.3. Cancellation may occur in the following cases:
  - when the call for tenders fails i.e. when no bid worthy of selection on the basis of quality and/or finance is received or when no bid was received;

- When technical or economic project items are significantly modified;
- When exceptional circumstances or *force majeure* make standard performance of the project impossible;
- When all technically compliant bids exceed available financial resources;
- When there are procedural irregularities, which notably prevent fair competition.
- 12.4.In case of cancellation, all bidders shall be informed in writing, as soon as possible, about the grounds of cancellation.
- 12.5. After the procedure is cancelled, ENEO Cameroon S.A. may decide
  - to launch a new call for tenders;
  - not to sign any contract;
  - to start negotiating with one or more bidders who participated in the procedure, provided the terms and conditions applicable to specifications are not substantially modified;

### 13. Acceptance

ENEO Cameroon S.A. shall not be obliged to accept the lowest bid. The contract shall be awarded to the bidder whose bid fulfils the requirements of this call for tenders and is the most beneficial to ENEO Cameroon S.A.

The call for tenders shall be awarded after compliance investigations have been finalised. ENEO Cameroon S.A. shall reserve the right to further investigate information provided by bidders.

#### 14. Contract Form

The selected bidder shall have to sign a Formal Contract with ENEO Cameroon S.A.

#### 15. Registration Fees

In case a Contract is signed, such shall have to be registered by the Service Provider, pursuant to existing tax regulations in the Republic of Cameroon.

These registration fees shall not be reimbursed by ENEO Cameroon S.A.
